## 2019 CRCA PAC DONATIONS NEEDED!

**CRCA constantly keeps up with the pulse of Springfield and Chicago**, with a watchful eye on legislation that directly affects the roofing, waterproofing and construction industry. By developing relationships with IL legislators, other industry lobbyists and by having members contact their legislators directly, CRCA provided support to the following 2018 legislative efforts:

- Defeating Gov. Rauner’s Repeal of the Roofing Licensing Act
- Overrode Gov. Rauner’s Veto of HB 732 – limiting building owners employees’ scope to “roof repair” only. *Roof Replacement, Roof Recover* and *Torching* must be performed by an Illinois Licensed Roofing Contractor.
- Fought legislative efforts to ban the sale of Coal Tar Sealants

### **IN 2019, CRCA EFFORTS INCLUDE:**

- Retainage – SB 1636 would reduce retained payments to subcontractors from current 10% to 5%, once 50% of the work is completed. Passed IL Senate in March and moved to IL Rules Committee
- Procurement – SB 104 would allow the state to pay subcontractors directly in select construction contracts if the work follows specific provisions. Moved to Rules Committee on May 10, 2019
- Wage Payment – HB 2838 would make GC’s liable for wages if the subcontractor does not provide. Passed the IL House waiting for assignment

**WITH OVER 7,000 BILLS INTRODUCED** every session, CRCA stays on top of proposed legislation that can affect the Illinois Roofing Industry. CRCA Lobbyist Margaret Vaughn works with other industry associations such as IL Mechanical Specialty Contractors Association (IMSCA) creating a larger impact.
